

Los Angeles County Domestic Violence Council General Meeting 900 S. Fremont Ave., Room C Alhambra, CA 91803

Minutes of October 16, 2018

1. Introductions/Announcements

The meeting was called to order by Executive Director, Eve Sheedy, at 12:10 p.m.

All attendees introduced themselves.

Renee Sotile, Mary Jo Godges, and Margarita Sweet introduced themselves and spoke about their music video project, I Remember Nicole. They encouraged attendees to view the video and share it for marketing or outreach purposes in raising awareness of domestic violence.

2. Update/Comments from Executive Director

Ms. Sheedy reported the following updates:

- Ms. Sheedy met with the County's Commission on the Status of Women. The Commission is very supportive of the Domestic Violence Council (DVC) and may be a source of funding for the re-publication of "It Shouldn't Hurt to Go Home."
- Ms. Sheedy is a member of the Los Angeles County Homeless Initiative Conference Planning Committee. The conference is in February.
- Los Angeles County domestic violence shelter contracts are now being handled by the Department of Public Health, Office of Women's Health (OWH). Ms. Sheedy conducted a domestic violence training for OWH.
- Ms. Sheedy is working on the Board report, which is due on November 13, 2018. Some of the items to be included in the report will be recommendations for committee restructuring, revising the bylaws, and broadening the DVC vision to include the voice of survivors and the community.
