

Los Angeles County Domestic Violence Council General Meeting 900 S. Fremont Ave., Room C Alhambra, CA 91803

Minutes of November 20, 2018

1. Announcements

The meeting was called to order by Executive Director Eve Sheedy at 12:05 p.m. Ms. Sheedy initiated a moment of silence in honor of Transgender Day of Remembrance, then introduced Mieko Failey. Ms. Failey invited attendees to share their pronouns during introductions in order to dismantle traditional binary roles and to be more inclusive. She reiterated that this was an invitation, not a requirement, and those who do not wish to share their pronouns will also be supported.

2. Update/Comments from Executive Director

Ms. Sheedy reported the following updates:

- The California Partnership to End Domestic Violence (CPEDV) may issue a budget request for more housing.
- A family justice center is planned for the Martin Luther King, Jr. Health Center in Service Planning Area (SPA) 6.
- Ms. Sheedy submitted the Board report to Dr. Barbara Ferrer, Director of Los Angeles County Department of Public Health (DPH). The report was submitted to the Board of Supervisors from DPH.
- There will be a standing Immigration Update item on the agenda for each DVC General Meeting.

3. Safety Cards

Erika Martinez from the Department of Public Health, Office of Women's Health (OWH) requested that interested parties complete the domestic violence safety card survey.

4. Introductions

Niki Madrid, Health Program Analyst III, introduced herself as the new team member in the office of the Domestic Violence Council.

All attendees introduced themselves.

Ms. Madrid reported that she will schedule a meeting with the volunteers to revise the *It Shouldn't Hurt to Go Home* booklet.

The LGBTQ Issues Committee met in November and discussed goals for next
year. They also discussed emerging issues and barriers for LGBTQ survivors
and updating language to be more inclusive. Ms. Failey reported that the
committee will be meeting monthly beginning in January 2019.

Shelter Directors – Co-Chairs Tatiana Dorman and Patima Komolamit The Shelter Directors Committee met in October. They assessed bed availability data applications and decided to move forward with DVIRC.

6. <u>Immigration Update</u>

Brigit Alvarez of the Legal Aid Foundation of Los Angeles (LAFLA) presented an update on immigration issues. She reported an increase in fee waiver rejections and discussed a new policy that results in a notice to appear for denied applications. She noted that more immigrants are afraid to apply for government assistance and to report crime.

8. <u>Panel Discussion: How DV Service Providers and Batterers Intervention</u> Programs Can Work Together

Moderator Nicole Perras asked the panelists to introduce themselves:

- Iliana Tavera Executive Director, Haven Hills
- Mary Case Program Manager for the Legal Advocacy Project for Survivors, Los Angeles LGBT Center
- Kendall Evans Association of Batterers Intervention Programs (ABIP);
 Director, Another Way
- Christy Stillwell Advocate, runs batterers intervention program at Homeboy Industries

The panel discussed how survivors and batterers groups can work together. Some suggestions were:

- Cross-training and collaboration
- Careful assessment to suit the needs of individual clients
- Ensure a trauma informed continuum of care
- Treat the whole problem (survivors and batterers), not half the problem (survivors only)
- Change the language and gender binary: *empowerment* group, rather than *survivor's* or *victim's* group and *stress and power management* group, rather than *batterer's* group.

The panel agreed that survivors' safety is a priority, and acknowledged that shelters are often a last resort when clients are fleeing for safety. However, the panelists welcomed the conversation of exploring how organizations can work together to help end the cycle of domestic violence. The panelists concurred that cross-training, partnerships, and collaboration were some first steps to working together within the framework of building healthy relationships.

The panel responded to questions/comments from attendees.

9. Public Comments - Not to exceed two minutes per person and must be on items of Interest which are within the subject matter jurisdiction of the Council

The South Asian Helpline and Referral Agency (SAHARA) in Artesia, CA is hiring a full-time Elder Abuse Victim Specialist. SAHARA also invites conversations and collaboration with other agencies who also address elder abuse.
