# Minutes of May 21, 2019

# 1. Announcements and Introductions

The meeting was called to order by Executive Director Eve Sheedy at 12:00 p.m.

### 2. Approval of Previous Minutes

A motion was made to approve the April minutes and was seconded. The motion carried with no nays or abstentions.

### 3. **Update/Comments from Executive Director**

Ms. Sheedy reported the following updates:

- Ms. Sheedy will meet with Bobby Cagle, Director of the Los Angeles County Department of Children and Family Services (DCFS) and will report back
- Ms. Sheedy visited the LA Hospitality Training Academy and informed the audience about their ongoing program to provide training for survivors of DV/HT
- The Domestic Violence Council (DVC) is working on a plan to offer transportation and stipends for survivors to participate in meetings
- Volunteers are needed for an ad-hoc committee to plan awards for Domestic Violence month in October
- The Executive Board met and will be grandfathered to a Steering Committee that will to oversee the work of the DVC

# 4. <u>Immigration Update</u>

- There are new forms to be used for U-Visa applications; old forms are only good until July 2
- There is a possibility that proof of public benefits will no longer be accepted for fee waivers

# 5. Policy Update

- California Senate Bill 144 eliminates the \$500 minimum mandatory fee for persons placed on probation pursuant to Penal Code Section 1203.097. The bill is currently pending in the Senate.
- California Assembly Bill 1449 (Garcia) states that a DV victim's conduct with law enforcement at the scene of the crime cannot be considered in determining reasonable cooperation in terms of receiving victim witness compensation. The bill also states that a claim for restitution by a DV, sexual assault or human trafficking victim cannot be denied solely because the victim delayed reporting the crime to law enforcement. The bill is currently pending in the Assembly.
- California Assembly Bill 67 (Rivas) requires the California Department of Housing and Community Development (HCD) to develop a statewide homeless

integrated data warehouse, which will be compiled from agencies' Homeless Management Information Systems (HMIS). Because most survivors are not entered into HMIS for safety and privacy reasons, there is a concern that the data warehouse will not accurately reflect the prevalence of domestic violence and sexual assault among homeless individuals and the needs of homeless survivors. The bill is currently pending in the Assembly.

• The U.S. Department of Housing and Urban Development (HUD) recently released a proposed rule prohibiting "mixed-status" families from living in federally subsidized public housing and Section 8 programs.

# **COMMITTEE REPORTS**

# A. Los Angeles Regional Policy Committee Meeting, April 18, 2019

Introductions and Announcements - Call to Order by Nancy Volpert, Co-Chair

### **Pending 2019 Legislation**

#### State

Discussions were held over legislations passed over last month or other bills people felt were important for follow up.

AB12 – Diane reported this appeared to be clean up legislation, which inter alia extended duration up to five years. Continued monitoring appeared appropriate.

AB 24- Amy recommended continuing to monitor. More information should be available at the following website: https://www.endchildpovertyca.org/author/grace/

AB61 – Diane reports that this bill is on the CPEDV list. Committee agrees this bill, which expands who may be a GVRO petitioner is worth continued monitoring. Diane provided an explanation of GVROs.

AB67 – Nancy brings this bill to attention of committee as a "gut and amend" bill from its prior iteration. This is a reintroduction of homeless data bill, which does not contain any protections for the data of DV victims, no privacy or safety measures.

AB 164 – Bill has been referred to suspense file, but no objections noted to the bill

AB 196 – Amy reports concerns with this paid family leave bill from Legal Aid at Work, noting that it is a regressive tax what will not help low wage workers because it does not offer job protections. Nor is there any requirement of employer contribution to the disability benefit.

AB 445 – Marci reports no change since last meeting

AB917 – Bill in which local concerns diverge from CPEDV support. Bill is on suspense due to costs exceeding \$50K.

SB 135 – Amy reports on the "good" paid family leave bill, that includes job protections and extends to smaller employers and part time employees.

SB360 – Good discussion was held on the issue of penitential privilege and mandated reporting. Continue to monitor, RJ and Diane volunteered.

#### Federal

House passed VAWA improvement bill

#### Local

City DVSO grants will be same as last year; no expected challenges to those numbers, City budget needs to be voted on by May 15 and the State budget by June 15. No significant changes on County funding.

# **Emerging Issues**

AB 1559 Melendez - Diane reported on a bill supported by Riverside Sheriff's Department offering concealed carry firearms to those with reasonable fear of DV/SA. Diane to follow and bill to be added to the bill chart

AB 1449 Garcia – Diane reports on bill to change CalVCB eligibility to deny victims who are perpetrators or who actively interfere with an investigation (as opposed to current

restriction for failure to cooperate), bill worth watching. Amy volunteered to report on next time.

SB375 Durazo – Bill would eliminate filing deadlines for CalVCB. Cecelia volunteered to report on next time.

AB 628 – Eve expressed concerns that it will allow abusers time from work for sexual harassment. Bill too broad, Amy and Diane to monitor.

SB435 Moorlach – Technical Family law bill – if anyone is interested FVAP/CPEDV is sponsoring a call this afternoon, materials distributed

SB 144 Mitchell – bill to decriminalize poverty would eliminate DV fines/penalties which could have a negative impact on shelter funding. Continued monitoring is necessary

No matters not on the posted agenda offered.

Public comment: Jerilyn asked about parking gate code and host Thien provided gate code.
