

## Los Angeles County Domestic Violence Council General Meeting 900 S. Fremont Ave., Alhambra Room Alhambra, CA 91803

## Minutes of July 16, 2019

#### 1. Announcements and Introductions

The meeting was called to order by Executive Director Eve Sheedy at 12:00 p.m.

#### 2. Approval of Previous Minutes

A motion was made to approve the June minutes and was seconded. The motion carried with no nays or abstentions.

## 3. Update/Comments from Executive Director

Ms. Sheedy reported the following updates:

- The *Reaching Out* booklet is being reprinted. We have distributed nearly 10,000 copies.
- The Los Angeles Hospitality Training Academy (HTA) received a "Recipe for Success" grant to provide training in hospitality fields for DV and HT survivors.
- The October and November meetings will be held jointly with the Los Angeles City Domestic Violence Alliance. The November meeting will not be in Alhambra.
- Committee reports will be posted on the Domestic Violence Council (DVC) website.
- The Department of Public Health (DPH) is working on a department-wide process to provide stipends for community members with lived experience to encourage attendance and participation in meetings, committee work and other projects.
- There is no meeting in August.
- Ms. Sheedy will report back to the Board of Supervisors with a progress report of the DVC by the end of August.
- Invitations for the Steering Committee will be sent out by the end of the summer.

#### 4. Immigration Update

Michelle Carey presented an immigration update.

- A new policy states that asylum seekers who pass through another country before entering the U.S. must first apply for entry to the U.S. in the other country. The ACLU and other legal groups are suing to block the policy.
- There is renewed ICE enforcement. Advocates are advised to help clients stay informed. Some useful resources are:

## 5. Policy Update

- Assembly Bill 668 (Gonzalez) prohibits civil arrest of anyone at a courthouse who is attending a court proceeding or handling a legal matter. The bill passed the Assembly and will be heard in the Senate Appropriations Committee on August 12, 2019.
- Assembly Bill 381 (Reyes) specifies that college student orientations must include the following information relating to intimate partner and dating violence: warning signs, campus policies and resources, off-campus resources, and prevention/bystander intervention. The bill passed the Assembly and the Senate and is currently on the Governor's desk.
- Assembly Bill 624 (Gabriel) requires schools 7 through 12 to include the National Domestic Violence Hotline and National Sexual Assault Hotline on student identification cards, starting July 1, 2020. The bill passed the Assembly and has moved to the state Senate.,
- Assembly Bill 656 (Garcia) creates an Office of Safe and Healthy Communities (OSHC) under the direction of the State Department of Public Health to provide a comprehensive violence prevention strategy and expand access to communitybased programs for Californians at risk of involvement in violence. The bill passed the Assembly and will be heard in the Senate Appropriations Committee on August 12, 2019.
- Update for Senate Bill 144 (Mitchell/Hertzberg): Elimination of all criminal fees and fines The bill is now a two-year bill, which means that it will not move forward this year and will be taken up again in the next legislative session.
- Update for Assembly Bill 917 (Reyes): Reduced Timeline for Processing U Visa & T Visa Law Enforcement Certification Requests The bill passed the Assembly and is currently in the Senate Appropriations Committee's suspense file. The bill must be voted out of the suspense file after the legislature reconvenes in August in order to move forward.
