

### Bernita: History of the DV & Religions Committee

- Committee began as a "TASK FORCE" around 2001
- During the 5 years we had participated in 4 DV Conferences that were hosted by the DVC
- On April 13, 2006, fulfilling the requirement for "a committee" of the DVC, committee request letter was submitted.

### Bernita: Need For Establishing Committee

- In 2004-5 Task force members participated in the 'Train the Trainer' project through the California State Department of Health Services Faith Leaders and Domestic Violence Advocate Project.
- Teams were formed throughout California to address the gap in the service to survivors and their Faith/Worship institutions.

### Bernita: Past Activities

- Each year until 2017, a 10 hour training was held by the committee with the out come to tighten the relationship with places of Faith and the issues of DV.
- In 2018, We became apart of the United Faith Network, birthed through Jenesse Center, as the concept was to move forward with larger places of Worship with the same idea in mind. Covid interrupted the progress.

- Clients identified their faith as a source of support but expressed feeling unsupported, confused, retraumatized after they approached faith leader regarding DV.
