Temporary Occupancy of Recreational Vehicles Eligibility Checklist

The Interim and Supportive Housing Ordinance enables temporary occupancy of RVs in very limited circumstances in order to provide a safe living situation for people experiencing homelessness during a County-declared shelter crisis. The intent is for a homeowner to be able to let a friend or family member who is having a difficult time occupy one RV on their property if the property meets certain requirements.

Where will occupied RVs be allowed? What are the requirements?	The Interim and Supportive Housing Ordinance temporarily allows one occupied RV in the rear of a lot that: Is zoned A-1, A-2, R-A, R-1, R-2, R-3, R-4 or R-5 Contains a legally-built, owner-occupied single-family home Is at least 5,000 sq ft Additionally, the Ordinance includes the following requirements: The homeowner cannot charge rent for the RV or the parking space The RV must be in working condition The RV cannot be parked in a setback area near the property line A minimum of 6 feet is required between the occupied RV and the main house and between the occupied RV and any other building on the lot Wastewater dumping in or around the lot is prohibited unless the homeowner provides documentation of proper facilities for disposal on-site No structure, such as decks or porches, can be attached to the RV Occupancy of the RV must end within 30 days after the expiration of the
Does the ordinance allow occupied RVs on vacant properties?	No. Occupied RVs are not currently allowed on vacant properties, and the Ordinance will not change this. In the approval of the Ordinance, the Board included a revision to further clarify that occupied RVs are prohibited on vacant lots and on lots where the single-family home is rented: http://file.lacounty.gov/SDSInter/bos/supdocs/150488.pdf
Where should the RV wastewater be disposed?	The County encourages the use of public wastewater disposal sites listed on the back of this form. These sites may charge a fee for disposal. If the property owner wishes to connect the RV to the site's septic system, the property owner must complete the Department of Regional Planning's Temporary RV Occupancy Form, where DRP will certify the property's eligibility to host an occupied RV. The property owner must take this form to the Department of Public Health to obtain approval for the septic system connection.
