



# Invasive Meningococcal Disease: 2017

## Los Angeles County Epidemiology Report

### October 20, 2017



No new cases of invasive meningococcal disease (IMD) were reported this week in LAC. The total number of IMD cases in LAC for 2017 is 10, including two fatalities (Table 1). All 3 serogroup C cases in LAC are outbreak-associated, though do not have direct social links to each other or other outbreak cases. The regional outbreak caused by serogroup C has been ongoing since March 2016. Of the 33 regional outbreak-related cases, most are MSM\*, and cases are from jurisdictions throughout Los Angeles, Orange, and Ventura Counties. LAC DPH and neighboring health departments continue to partner with the California Department of Public Health (CDPH) and Centers for Disease Control and Prevention (CDC) to investigate. No common social linkages among outbreak-associated cases in the region have been identified. Recent increases in IMD in LAC highlight the importance of observing meningococcal vaccination recommendations for certain high risk groups (see box). Providers should implement evidence-based practices to ensure completion of the 2-dose vaccination schedule for all HIV-infected persons.

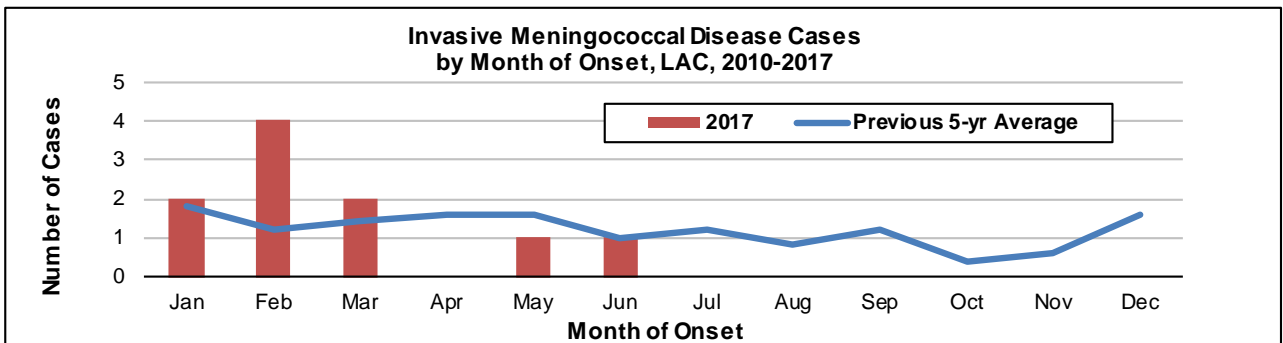

### Recommendations and Resources

LACDPH recommends meningococcal conjugate vaccine be offered to:

- All MSM, regardless of HIV status;
- All HIV-infected persons.

Routine vaccination is recommended for all persons 11-12 years of age, with a booster dose at 16 years.
