Vaccine Ordering at Skilled Nursing Pharmacy

- All vaccine orders are placed for a specific resident.
- Pre Booking bulk ordering does occur, but is mostly for Influenza Vaccine orders.
- Orders are recommended to be placed electronically (Ex: PCC).

Processing Time

- **SNP processing time for Vaccines to be sent is within one day of receiving the order.**
- **Delays can occur:**
 - Manufacturer limited supply.
 - Back orders especially during peak vaccination time.
 - Noncovered high cost vaccines.

Anticipation of 2025-2026 Vaccines

Covid-19 Current Recommendation

- [Key health care organizations](#) recommend that all individuals aged 6 months and older be offered updated COVID-19 vaccines as they become available.
- Adults 65 years and older are recommended to receive 2 doses of any updated COVID-19 vaccine separated by 6 months (minimum interval 2 months) regardless of vaccination history.

Getting the updated COVID-19 vaccine is especially important if you:

- Never received a COVID-19 vaccine.
- Are ages 65 years and older.
- Are at high risk for severe COVID-19.
- Are living in a long-term care facility.

Anticipation of 2025-2026 Vaccines

Influenza Vaccine

- CDC recommends everyone aged 6 months and older get an annual flu vaccine, ideally before the end of October before flu starts circulating.
- Important for people at high risk for developing serious complications from flu, including:
 - People 65 years and older,
 - People with chronic medical conditions (i.e., heart, lung, kidney, and liver disease) including obesity, asthma, diabetes or weakened immune systems.
 - People who live in nursing homes or long-term care facilities.

For those aged 65 years and older – High-dose, recombinant, or adjuvanted flu vaccines are recommended if they are available:

- Fluzone
- Flublok
- Fluad

Anticipation of 2025-2026 Vaccines

- FDA has advised the COVID-19 vaccines in fall 2025 should be monovalent JN.1-lineage-based COVID-19 vaccines (2025-2026 Formula).
- FDA has also approved the composition of the Influenza Vaccine 2025-2026.
- Currently the 2025-2026 vaccines are unavailable at Skilled Nursing Pharmacy.
- Expected date of availability is August/September.

Consent Process

- Medicare regulations require nursing homes to offer residents the influenza (flu), Pneumococcal and COVID-19 Vaccinations, and education regarding these vaccinations.
- Consent is a common practice, and is required for COVID-19 vaccination.
- If a resident is unable to communicate or make decisions about their vaccination, consent can be provided by a medical proxy or substitute decision-maker appointed to make medical decisions on their behalf.
- Documentation of consent or assent must be recorded in the resident's medical chart according to the provider's standard practice.

Scheduling Clinics

- Skilled Nursing Pharmacy is not currently offering vaccination clinics.
- Pharmacies serving long-term care facilities can be found through resources like the LA County Department of Public Health.

Helpful Tips

- **Be Proactive**

- Follow up with pharmacy regarding availability of new Vaccines (August and September).
- Stay in contact with your pharmacy team (Consultant Pharmacist, Nurse Consultant, Customer Success Managers).

- **Be Prepared**

- Set up project leader
- Determine Vaccine Needs
- Explore facility billing/Cost
- Review facility policies
- Explore scheduling options
- Plan vaccine administration
- Document vaccinations

Champion Facility #1

- Facility is highly proactive with vaccine follow up.
- Facility Staff (nursing, DON, and Administrative) make a strong effort to follow up on new vaccine availability during the COVID-19 and Flu season.
- This facility works closely with there Skilled Nursing Pharmacy customer success manager, and consultant pharmacist.

Champion Facility #2

- Facility finds major success through proper planning.
- Infection Prevention control nurse is given the responsibility for planning Vaccine Administration, and Clinics.
- Facility started planning early (late June/Early July)
- Planning that has already occurred:
 - Vaccine cost for facility and residents
 - Vaccine need
 - Order Entry
 - Possible days for a Vaccination clinic/administration day

Specialized Patient Care Leading to Outstanding Outcomes

Successful Vaccination Programs in Skilled Nursing Facilities

- Free Vaccination Clinics for facility, residents and staff
 - Offer staff vaccinations during every vaccine clinic
- No minimum number of vaccines required
- Scheduled/frequent recurring vaccine clinics
- Experts in ACIP/CDC recommendations and vaccine schedules
 - Underlying medical conditions, past vaccination history, age qualification, past vaccine reactions, allergies, etc.
- Resident vaccine evaluations to evaluate for eligible vaccines
- Insurance expertise – Medicare Part B, C, D, Medi-Cal, etc.
 - Prior authorizations / Insurance overrides (PACE programs, narrow network plans, immunizations billed but not administered), eligibility issues

Successful Vaccination Programs in Skilled Nursing Facilities

- Access to free vaccines for uninsured staff (Bridge Access Program COVID vaccines, State General Fund flu vaccines)
- Access to free vaccines for residents without insurance to cover vaccines (Ex. Medicare A only, VA)
- Consistent communication (phone, emails) between vaccine provider and IP Nurse / DSD / DON to provide information on vaccination rates, hospitalization rates, outbreaks, reinforce CDC and DPH updates, clinic scheduling reminders, updated vaccine recommendations, etc.
- Schedule vaccine clinics on short notice if needed
- Educational in-services for staff, residents and families

Successful Vaccination Programs in Skilled Nursing Facilities

- Flexible vaccination plans (room-to-room, common areas, dining room, activity room, smoking patio – finding residents)
- Provide education and a friendly face at bedside to minimize vaccine refusals
- Verification of vaccination history in CAIR and SNF vaccination records no more than 24 hours prior to vaccine clinics
- Ease the burden on IP Nurses that encourages them to continue scheduling clinics
 - Report all vaccines to CAIR and other Immunization Registries (ex. RIDE)
 - Stewardship for vaccine consent forms – staff turnover can lead to misplaced forms at the SNF

Successful Vaccination Programs in Skilled Nursing Facilities

- Assistance with P/P review to ensure SNF policies are updated with the most recent CDC guidance
- Access to the most current Vaccine Information Sheets (VIS) for each vaccine for resident and/or representative
- Access to updated SNF specific Vaccine Consent / Declination Forms
- Focused Vaccine Specialty Provider – never interfere with services of other providers
- Ease of communication, requesting vaccine clinics and documentation submission
 - Secure Portal, Fax, Email, QR code



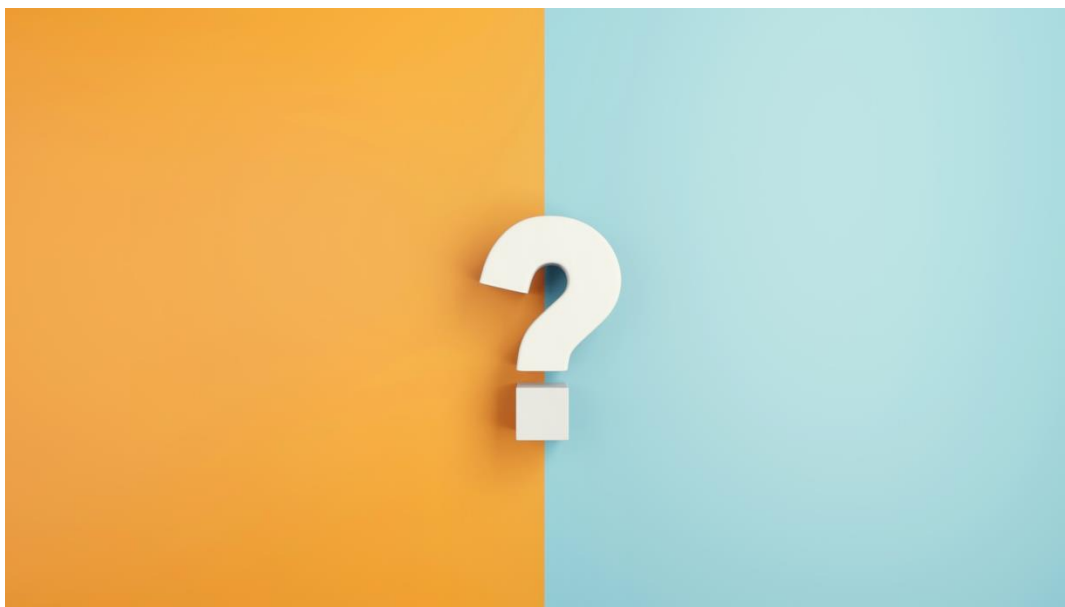
Corporate Partnerships Optimize Vaccination

- Minimize unreimbursed SNF vaccine expenditure, expired and wasted vaccines and vaccines administered without reimbursement (Residents and staff)
- **Plan for Fall vaccine billing – Medicare A and Employees**
- Optimize Medicare Part B vaccine administration to Medicare Part A residents to create a profit center
- Direct billing to Medicare Advantage Plans (Medicare Part C)
- Resolve vaccine coverage issues for residents with Medicare Part A only, Medicare Parts A and B without a Medicare Part D plan, residents in PACE programs, residents in narrow-network plans

Corporate Partnerships Optimize Vaccination

- Collaborate to create a crosswalk for SNF Administrators and IP Nurses who are uncomfortable with authorizing vaccine charges leading to sub-optimal vaccination rates
- Participate in multi-disciplinary team pre-admission process – Plan vaccination prior to hospital discharge for resident with Medicare Part A only
- Medicare Part D education, right-to-choose, information and benefits of a Part D plan upon admission
- Coverage for entire state of CA to ease the corporate burden

Vaccine Management Reminders

- COVID-19 vaccines are available in single dose vials and syringes
 - 10 doses are available in each box
- mNEXSPIKE (Moderna) and NUVAXOVID (Novavax) are new COVID-19 vaccine products approved for use in 65+ population
 - MNEXSPIKE is approved for use in individuals who have been previously vaccinated with any COVID-19 vaccine
 - MNEXSPIKE and NUVAXOVID are also indicated for individuals 12 through 64 years who have at least one underlying condition that puts them at high risk for severe outcomes from COVID-19
- Flu vaccine always expires at the end of May or June
 - The upcoming season expiration will be June 30, 2026
- Order Flu vaccine in multiples of 10 doses (10 doses, 20 doses, 30 doses, etc.)



Vaccine Management Reminders Cont.

- RSV vaccine for adults is available in 3 products: Abrysvo (Pfizer), Arexvy (GSK), mRESVIA (Moderna)
- RSV vaccine expiration date is 18 months (Abrysvo; mRESVIA) from the manufacture date or 24 months from the manufacture date (Arexvy)
- A single dose of any FDA-licensed RSV vaccine is recommended for all adults ages 75 and older and adults ages 50–74 at increased risk of severe RSV.

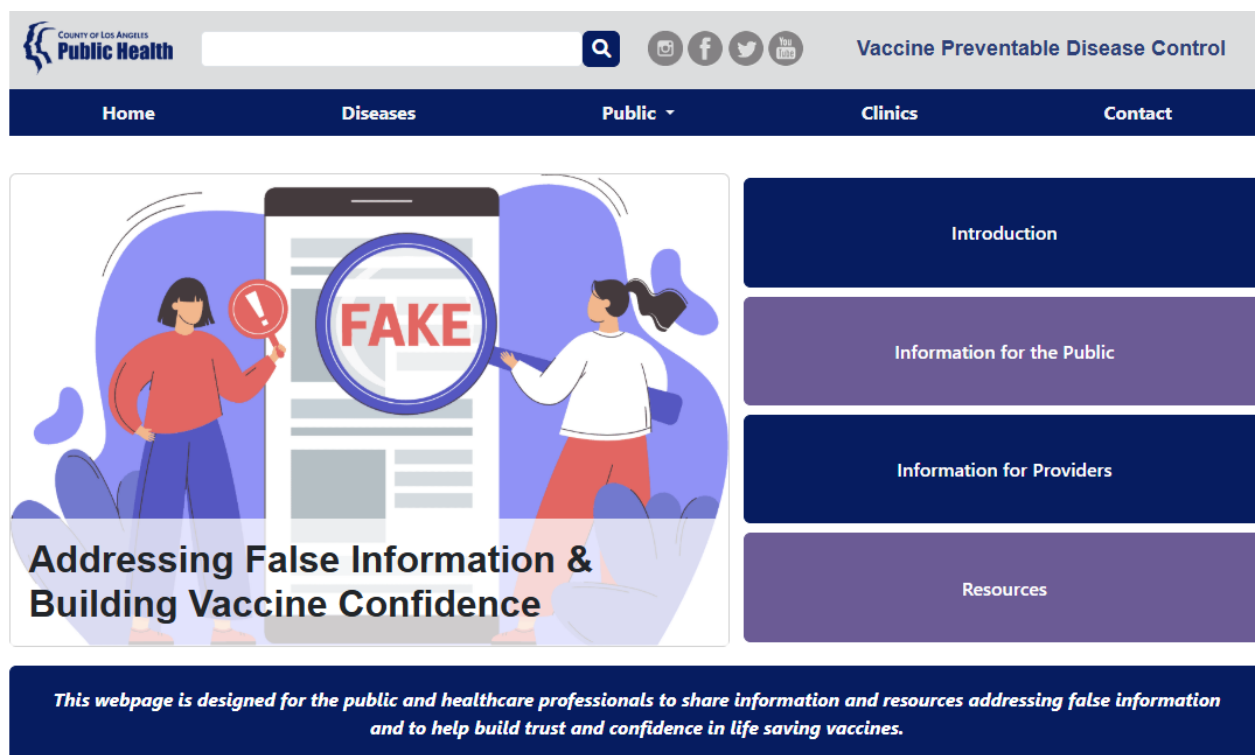


Current COVID-19 Vaccine Recommendations

- Recent federal policy statements and changes have raised questions and confusion about recommendations and access to COVID-19 vaccines.
- COVID-19 vaccines continue to be important tools to prevent severe disease in vulnerable populations.
- CDPH recommends that all individuals age 6 months and older should have access and the choice to receive currently authorized COVID-19 vaccines, with an emphasis on protecting higher risk individuals, such as infants and toddlers, pregnant individuals, and others with risks for serious disease.
- Insurance coverage for COVID-19 vaccines is still in place.
- Adults 65 years and older or immunocompromised are recommended to receive two doses of the 2024 – 2025 COVID-19 vaccine separated by 6 months (minimum interval 2 months). *To be considered “Up-to-Date”, they must have received the 2nd dose.
- COVID-19 activity is rising. While COVID-19 seasonality is uncertain, a summer wave is expected. Majority of COVID-19 burden from last year occurred during the 2024 summer wave. Older adults and young children continue to have the highest COVID-19 hospitalization rates.

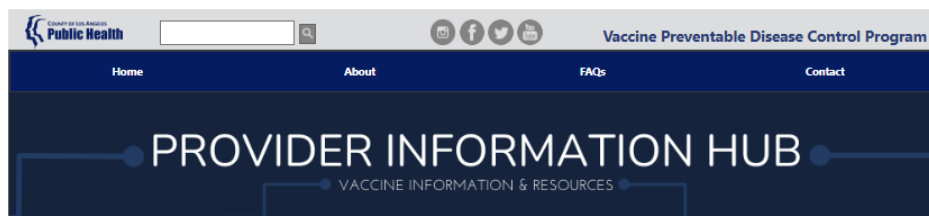
