Urgent Updates

Respiratory Virus Surveillance in LA County

The activity of respiratory viruses, including flu, COVID-19, and RSV, is on the decline in Los Angeles County. It's important to remain vigilant, especially with the changing patterns of respiratory illnesses.

Updated Masking Requirements

With the end of the Respiratory Virus Season Health Officer Order on April 30th and low CDC hospitalization levels, unvaccinated healthcare personnel are no longer required to mask at all times in patient care areas. Standard precautions, including wearing a well-fitting mask around symptomatic individuals, are still strongly recommended. For more information, visit CDC Standard Precautions.

Health Services Advisory Group (HSAG) No-Cost Clinics

Health Services Advisory Group (HSAG) recently partnered with local pharmacies statewide to provide certain vaccines (including COVID-19 and pneumonia) at no cost. This partnership aims to ensure that all skilled nursing facility (SNF) residents and staff, regardless of insurance status, have access to the protection offered by vaccination. Lead Poisoning from Vietnamese Hemorrhoid Ointment

A fatal case of lead poisoning in Sacramento linked to Cao Bôi Trĩ Cây Thầu Dầu, a hemorrhoid ointment from Vietnam, has been reported. Healthcare providers should urge patients to stop using this product and get a blood test immediately. For more details, see <u>CDPH Advisory</u>.
