Question: What does ICAR stand for?

**Answer:** ICAR stands for Infection Control Assessment and Response.

Question: Can you share the regulation about the medical director certification for nursing homes?

**Answer:** The California Assembly Bill 749, issued 10/07/2021:

This bill would prohibit a skilled nursing facility from contracting with a person as a medical director if the person is not, or will not be within 5 years of the date of initial hire as the facility's medical director, certified by the American Board of Post-Acute and Long-Term Care Medicine, or an equivalent organization as determined by the department, as a Certified Medical Director. Under the bill, a medical director already employed in a skilled nursing facility as of January 1, 2022, would have until January 1, 2027, to become a Certified Medical Director. More information on how SNFs should comply with this regulation can be found in CDPH AFL 21-46: <a href="https://www.cdph.ca.gov/Programs/CHCQ/LCP/Pages/AFL-21-46.aspx">https://www.cdph.ca.gov/Programs/CHCQ/LCP/Pages/AFL-21-46.aspx</a>, which state that all SNFs should report to CDPH no later than June 30, 2022 the name and certification status of the facility's medical director.
