**ADDENDUM NO. 3
TO REQUEST FOR PROPOSALS (RFP)
FOR LABORATORY COURIER SERVICES**

On March 10, 2011, the Los Angeles County, Department of Public Health (DPH), in collaboration with the Department of Health Services (DHS), released a RFP to solicit proposals from qualified laboratory courier contractors for the provision of services transporting laboratory specimens, reports, supplies, and other materials to and from designated locations within Los Angeles County.

As indicated in the RFP, Paragraph 1.5, County Rights & Responsibilities, the County may amend the RFP by written addendum. This Addendum No. 3 amends the RFP as indicated below:

1. Attachment I shall be added to the RFP as County's response to questions posed at the Mandatory Proposers' Conference held on April 6, 2011.
2. RFP, Paragraph 2.3, RFP Timetable, shall be amended to revise deadlines as follows (Note: revisions are identified in **bold font**):

"2.3 RFP Timetable

The timetable for this RFP is as follows:

- Release of RFP March 10, 2011
- Request for a Solicitation Requirements Review Due..... March 23, 2011
- Written Questions Due March 23, 2011
- Questions and Answers ReleasedApril 1, 2011
- Mandatory Proposers ConferenceApril 6, 2011
- Submission of Application for Exemption to
Living Wage Program due by 3 p.m., Pacific Time (PT).....April 15, 2011
- **Proposals due by 3 p.m., PT Monday, April 25, 2011"**

3. RFP, Paragraph 2.9.1 Proposer's Organization Questionnaire/Affidavit and Required Support Documentation, Required Support Documents, shall be amended to add the following reference point:

"3) Documents required in this section must be submitted for both the Contractor (Proposer) and Subcontractor."

4. RFP, Paragraph 2.9.8, Business Proposal Required Forms (Section F), shall be amended to add Exhibits 25A(DPH) and 25B(DHS), Routine Services - Route Transportation Mileage Calculation as well as supporting MapQuest web mapping documentation. (Mileage for Routine services must be based on MapQuest web mapping service.)
5. RFP, Paragraph 3.5, Cost Proposal Evaluation Criteria (30%), shall be amended to delete the first (1st) and second (2nd) paragraph in its entirety and replace as follows:

“DPH and DHS proposed budget amounts for Routine Route services will be combined and evaluated.

Routine Route and Non-Routine Route proposed service costs will be evaluated separately. In each category, Routine Route and Non-Routine Route, the maximum number of possible points will be awarded to the lowest cost responsive proposal. All other responsive proposals in each of the categories, Routine Route and Non-Routine Route, will be compared to the lowest cost and points will be awarded accordingly.

However, should one or more of the Proposers request and be granted the Local SBE Preference and/or Transitional Job Opportunities Preference, the cost component points in each category, Routine Route and Non-Routine Route, will be determined as follows:”

6. RFP, Appendix C, Technical Exhibit 3, Routine Route Schedule for Department of Health Services (pages 1-4) shall be deleted in its entirety and replaced with the attached Technical Exhibit 3, Routine Route Schedule – Department of Health Services.
7. RFP, Appendix D, Exhibit 14, Budget Sheet (Revised 4/1/11), DPH & DHS, shall be deleted and replaced with the attached revised Exhibit 14, Budget Sheet, DPH & DHS. (Please note that Exhibit 14 requires that transportation mileage for Routine Services be based on MapQuest web mapping service.)

ADDENDUM NO. 3
REQUEST FOR PROPOSALS (RFP)
FOR LABORATORY COURIER SERVICES
ANSWERS TO PROPOSERS QUESTIONS POSED AT
THE MANDATORY PROPOSERS CONFERENCE ON APRIL 6, 2011

Q1: Are Independent Contractors allowed?

A1: For the purpose of this solicitation, an Independent Contractor is defined as a Subcontractor. All Subcontractors must comply with the terms and conditions of the RFP and the resulting County Contract including, but not limited to, the Living Wage Ordinance, insurance requirements, and the provision of all required forms and applicable licenses, including proof from the California Secretary of State of the entity's business organization. The recommended Contractor must submit and obtain the County's approval of the sub-contract agreement prior to the Subcontractor's provision of services. Further specified in RFP, Appendix A, Sample Contract, Paragraph 8.40, SUBCONTRACTING.

All drivers must be employees of either the Contractor (Proposer) **OR** the Subcontractor, no exceptions.

Q2: How does the County verify that staff of the subcontractor are trained?

A2: As specified in RFP, Appendix A, Sample Contract, Paragraph 8.40, SUBCONTRACTING, sub-paragraph 8.40.4, "The Contractor shall remain fully responsible for all performances required under this Contract, including those that the Contractor has determined to subcontract, notwithstanding the County's approval of the Contractor's proposed subcontract." As such, Contractor will be responsible for ensuring that Subcontractor complies with Appendix A, Sample Contract, Paragraph 7.8, Mandatory Personnel Monitoring Reports.

Q3: What is the exact date of current contract expiration? Will the current contract be extended? For how long?

A3: The existing agreement is scheduled to expire on September 30, 2011. As stated in RFP, sub-paragraph 1.1, Purpose, it is the County's intent to award a separate contract with each Department to commence services immediately upon expiration of the current contract and ensure there is no gap in service.

Q4: May delivery personnel be allowed to wear clean, properly fitting uniform shorts?

A4: For drivers' safety, shorts are not allowed. As stated in Appendix B, Statement of Work, Paragraph 6.4.4, Uniform and Identification Badges, "Contractor's personnel must wear suitable uniforms with the name of the company on the uniform." An identification badge with picture of the driver, name of the driver, and company name is required to be worn at all times while performing contracted services. **No t-shirts, shorts, sandals, or open-toed shoes are permissible.**

Q5: Please explain the County approved equation to figure health benefits paid on behalf of employees as a cost/per hour?

A5: The Auditor-Controller obtained from the Department of Public Social Services (DPSS) the minimum gross earnings a participant would need to earn to become ineligible for cash assistance under the Cal/WORKS Program. DPSS provided the monthly gross amount of \$1,671 as the point of ineligibility based on the following: an average assistance unit of three (3) persons; based solely on an hourly wage; no income other than earned wages; and not including any employee benefits.

Based on gross earnings of \$1,671 and monthly work hours of 173.3 (40 hours per week x 52 weeks/12 months), the hourly rate was calculated to \$9.64. The cost of health insurance benefits was calculated to be \$2.20 per hour for a three person household. This amount was based on a weighted average of standard HMO costs per age group.

Q6: What is the County's guideline for mileage reimbursement for employees who use their own vehicles?

A6: The County's guideline for mileage reimbursement is not relevant to this solicitation.

Q7: What is the projected volume or frequency of Non-Routine or "Stat" deliveries?

A7: At this time, the County is not able to project the volume or frequency, but we anticipate that it will be minimal.

Q8: Is there any consideration for company payment in excess of health benefits more than \$2.20/hour?

A8: There is no consideration given. Proposers must comply with the Living Wage requirements.

Q9: Should both cost proposals (DPH & DHS) be included on each CD?

A9: No. One CD should be submitted with DPH data and the second with DHS data.

Q10: What specific licenses and certificates would you like us to include?

A10: As stated in RFP, Paragraph 2.9.10, Proof of all applicable Licenses/Certifications (Section H) "Provide a copy of **all applicable** licenses, certificates, permits, **for example**: business license, State of California DMV Motor Carrier Permit, etc." **Note**: The submission of employee licenses is not required. Evidence from the California Secretary of State of the business organization for both the Contractor and Subcontractor must be included as part of the supporting documentation to Proposer's Organization Questionnaire/Affidavit – Exhibit 1.

Q11: Section E, how would you like it done?

A11: The Section E requirement may be simply fulfilled by including the required statements on Company letterhead, signed by an authorized signatory.

Q12: Would you like the questions answered in number format, paragraph format, or bullet points?

A12: RFP, Paragraph 2.9.5 indicates "At a minimum, include responses to the following questions in the order specified". Therefore, it is appropriate to use the same numbering method to ensure the proposal is clear and "user friendly" and will enable the evaluators to easily find reference points.

Q13: Where do we include additional data, forms, training manuals, etc?

A13: No data in addition to that which is requested in the RFP is required nor will it be evaluated. Submit data in the Section in which it was requested. See RFP, Paragraph 2.9, Business Proposal Format.
