ADDENDUM NUMBER 5

TO REQUEST FOR STATEMENT OF QUALIFICATIONS (RFSQ) FOR SUBSTANCE USE DISORDER (SUD) SERVICES - SUD RFSQ 2012-004

On December 28, 2012, the County of Los Angeles (County) Department of Public Health (DPH) released a RFSQ to establish a qualified pool of vendors that are able to provide as-needed SUD services to adult and/or youth populations in Los Angeles County.

As indicated in the RFSQ, Paragraph 1.8, County Rights and Responsibilities, the County has the right to amend this RFSQ by written addendum. As such, DPH is issuing Addendum Number 5 to amend the RFSQ as indicated below:

1. Section 2.3, RFSQ Timetable, shall be deleted in its entirety and replaced by the following:

"2.3 RFSQ Timetable

Re-open of SUD RFSQ	July 13, 2015
Written Questions on RFSQ Due on or before	3:30 p.m., August 10, 2015
Response to Questions Released	August 24, 2015
Phase 1* – SOQ Due	3:30 p.m., September 9, 2015
Phase 2 – SOQ Due	Open Continuous

*SOQ that are submitted after the initial due date and time indicated above shall be considered for review at the convenience of the County.

All times as listed above and throughout this RFSQ are Pacific Time (PT)."

2. Section 2.5, Vendors' Questions, shall be deleted in its entirety and replaced by the following:

"2.5 Vendor's Questions

Vendors may submit written questions regarding this RFSQ by United States Postal Service (US mail) or electronic mail (e-mail) to the individual identified in Addendum Number 4 in RFSQ, Section 1.9, Contact with County Personnel. All questions must be received in writing by County no later than 3:30 p.m., August 10, 2015, PT (see Section 2.3, RFSQ Timetable).

When submitting questions, please specify the RFSQ section number, paragraph number, and page number, and quote the language that prompted the question. This will ensure that the question can be quickly found in the RFSQ. County reserves the right to group similar questions when providing answers and to disregard questions that are not relevant to the RFSQ process. All questions, without identifying the submitting company, will be compiled with the appropriate answers and issued as an Addendum to the RFSQ.

Questions may be about concerns that the application of minimum requirements, evaluation criteria and/or business requirements would unfairly disadvantage Vendors or, due to unclear instructions, may result in the County not receiving the best possible response from Vendor."
