**ADDENDUM NUMBER 1  
TO  
REQUEST FOR STATEMENT OF QUALIFICATIONS (RFSQ) #2018-006  
FOR  
AS-NEEDED ENVIRONMENTAL LABORATORY TESTING SERVICES**

On June 14, 2018, the County of Los Angeles (County) Department of Public Health (DPH) released a Request for Statement of Qualifications (RFSQ) for As-Needed Environmental Laboratory Testing Services.

Pursuant to RFSQ Section 1.8, County Rights and Responsibilities, DPH has the right to amend the RFSQ by written addendum. This Addendum Number 1 amends this RFSQ as indicated below (new or revised RFSQ language is shown in **highlight** or ~~strikethrough~~ for easy reference).

1. RFSQ, Section 1.4 Vendor's Minimum Mandatory Qualifications, Subsection 1.4.4, Vendors with Unresolved Disallowed Costs, is hereby amended to read as follows:

**"1.4.4 ~~Vendors with Unresolved Disallowed Costs~~**

If Vendor's compliance with a County contract has been reviewed by the Department of the Auditor-Controller within the last 10 years, Vendor must not have unresolved questioned costs identified by the Auditor-Controller in an amount over \$100,000 that are confirmed to be disallowed costs by the contracting County department and remain unpaid for a period of six months or more from the date of disallowance, unless such disallowed costs are the subject of current good faith negotiations to resolve the disallowed costs, **in the opinion of the** ~~contracting~~ **County** department.

County will verify ~~compliance~~ that Vendor does not have unresolved **questioned disallowed** costs."

2. RFSQ, Appendix A, Required Forms, Exhibit 2, Vendor's Organization Questionnaire/Affidavit and CBE Information has been replaced in its entirety to reflect the revised Minimum Mandatory Qualifications. The revised Appendix A, Exhibit 2 is **attached hereto, as Attachment I.**
