## ADDENDUM NUMBER 1 TO REQUEST FOR APPLICATIONS (RFA) FOR TRAUMA PREVENTION INITIATIVE: HOSPITAL VIOLENCE INTERVENTION PROGRAM RFA #2023-001

On February 1, 2023, the County of Los Angeles (County) Department of Public Health (Public Health) released Request for Applications (RFA) #2023-001 for the Trauma Prevention Initiative: Hospital Violence Intervention Program.

The addendum consists of two parts as outlined below:

- PART 1 MODIFICATION TO RFA
- PART 2 RESPONSE TO APPLICANTS' QUESTIONS

## PART 1 – MODIFICATION TO RFA

Pursuant to RFA, Section 1.7, County Rights and Responsibilities, the County has the right to amend this RFA by written addendum. This Addendum Number 1 amends this RFA as indicated below (new or revised RFA language is in **bold text** and deleted language is shown in strikethrough for easy reference).

RFA, Section 1.38, Prohibition from Participation in Future Solicitation(s), is amended to read as follows:

Addendum Number 1 RFA #2023-001 February 21, 2023 Page 2

Neither a Contractor nor An Applicant, or a Contractor or its subsidiary or Subcontractor ("Applicant/Contractor"), is prohibited from submitting a bid or application in a County solicitation if the Applicant/Contractor has provided advice or consultation for the solicitation. An Applicant/Contractor is also prohibited from submitting a bid or application in a County solicitation if the Applicant/Contractor has developed or prepared any of the solicitation materials on behalf of the County. A violation of this provision will result in the disqualification of the Contractor/Applicant from participation in the County solicitation or the termination or cancellation of any resultant County contract (Los Angeles County Code, Chapter 2.202).

## PART 2 – RESPONSE TO APPLICANTS' QUESTIONS

Pursuant to RFA, Section 2.0, Instructions to Applicants, subsection 2.6, Applicants' Questions, answers to questions received by the deadline are being issued as part of this Addendum.

- Q. Is this RFA only for non-profit organizations?
- A. Yes. RFA, Section 1.4 Applicant's Minimum Mandatory Requirements, subsection 1.4.1, Organization, states: "Applicant must be a tax-exempt, registered non-profit organization qualified under Internal Revenue Service's Code (IRS) Section 501(c)(3), and must submit a copy of its IRS 501 (c)(3) Determination Letter, serving residents of LAC."
