## ADDENDUM NUMBER 4 TO REQUEST FOR PROPOSALS NO. 2024-014 FOR COMPREHENSIVE HIV AND STD PREVENTION SERVICES IN LOS ANGELES COUNTY

On December 3, 2024, the County of Los Angeles (County) Department of Public Health (Public Health) released a Request for Proposals (RFP) for Comprehensive HIV and STD Prevention Services in Los Angeles County.

Pursuant to RFP Section 5.4, County's Right to Amend Request for Proposals, Public Health has the right to amend the RFP by written addendum. This Addendum Number 4 amends this RFP as indicated below, with new RFP language in highlight and revised or deleted language in strikethrough for easy reference.

RFP Section 8.4, Preparation of the Proposal, Subparagraph 8.4.2, Cover Letter, is revised as follows:

The Cover Letter must include the following:

- 1. A statement that includes the requested funding amount per category(s) for the proposal submitted in response to the Comprehensive HIV and STD Prevention Services in Los Angeles County RFP #2024-014;
- A statement indicating whether the Proposer intends to utilize subcontractor(s)/consultant(s) to perform any of the services, and if so, identification of each proposed subcontractor(s)/consultant(s) by name and service(s) to be subcontracted to the subcontractor(s)/consultant(s);
- 3. The name, telephone number, and email address of the Proposer's representative/contact person for the proposal submission; and
- 4. The signature of the organization's Executive Director, Chief Executive Officer, or other authorized designee.
