<p><b>Healthy Families</b> Provides basic mental health services to Healthy Families members. <p><b>Medi-Cal</b> Provides mental health services to Medi-Cal beneficiaries in need of medically necessary mental health services (all ages). <p><b>School-related psychological services</b> Mental health services are provided to students who demonstrate social, emotional, behavioral and/or trauma related problems, which inhibit their ability to learn. <p><b>Assembly Bill (AB) 3632 related services</b> Provides mental health services necessary for a child to benefit from education (ages 3-21).</p>	<p>Parent should contact child's special education coordinator</p>

<p><b>Family Resource Centers (FRCs)</b> Provide free information and parent-to-parent support for those caring for children with special needs (ages 0-3), including mental health conditions. <p><b>Supplemental Security Income (SSI)</b> Provides cash assistance and Medi-Cal to low-income, individuals with disabilities (all ages), including those with mental health disabilities.</p>	<p>(800) 772-1213</p>

<sup>1</sup> Children with serious emotional disturbance (SED) are under age 18 and have a mental disorder defined by the Diagnostic and Statistical Manual of Mental Disorders, other than a primary substance use or developmental disorder, resulting in developmentally inappropriate behavior. Children with SED meet one of the following criteria:

- A. Due to the mental disorder have severe impairment in two of the following areas: self-care, school functioning, family relationships, or ability to function in the community and either of the following occur: 1) the child is at risk of removal from home or has already been removed from the home, or 2) the mental disorder and impairments have been present for more than six months or are likely to continue for more than one year without treatment.
- B. The child displays one of the following: psychotic features, risk of suicide, or risk of violence due to a mental disorder.
- C. The child meets special education requirements under Chapter 26.5 (commencing with Section 7570) of Division 7 of Title 1 of the Government Code.
