### **MINUTES**

- I. Call to Order & Introductions Rachelle M. Neshkes, Gail Pincus, Kate Forrest, Co-Chairs
   \*hybrid testing Gail on Teams
- II. Law Enforcement Issues
  - a. LAPD updates:
    - Ria provides statistics: January to end of June = 20,429 IPV calls for service; 8,055 IPV crime reports
  - b. Report on DVC meeting with Sheriff's Department
    - Meeting w/ Luna was rescheduled, but Lan reports out on topics covered in co-chair meeting:
      - Refusal to serve DVROs, and the need for training on new laws regarding service (substantive review prohibited, and in January acceptance of electronic signatures);
      - Insufficient responses, issuance of EPOs
      - Need for LASD presence in stakeholder forums
      - Lack of understanding of IPV dynamics, especially among marginalized populations
      - o Problems getting reports taken for violations, and getting copies of reports
    - In regards to training, Gail suggests official memo/notice to CMB like LAPD does, and clarifies that we need a point person not only in meetings, but also contact for emergency situations

- Discussion of whether cross-entity collaboration with LAPD & LASD would be possible/productive to have a universal policy on handling DVROs
- Discussion of other possible training sources, including DVC member groups and San Diego Strangulation Institute
- Gail wants sheriff to report out on data for EPOs being issued; to remind them that they
  can issue EPO w/o victim's consent if responding officer thinks it's necessary
- c. Community inquiries re: official policies on taking reports of RO violations & courtesy reports
  - Shared Rachelle/LACLJ's questions, and Ria says she'll report back at a future meeting, and we can also add these to the topics to discuss w/ sheriff
  - Minty notes particular difficulty getting reports taken for coercive control; Pallavi notes she did a training for LAPD about this issue
  - Discussion of use of DART officers to spread the word about these issues, need for a concise statement if there are going to be materials distributed
  - Discussion of how to build best case for prosecution of violations
    - Officers could educate victims about how to document incidents, alternative ways of accessing 911
    - Full DVRO packets should be included in discovery package for DA to give them context/add'l evidence

### III. Court & Clerk Issues

- a. Processing of DVRO requests & continuances
  - Rachelle reports back from FLC meeting re Local Rule 5.3 updates: it will be clarified
    that DVROs can be filed at any time during the court day, including during the lunch
    break, it's just a question of processing time; regarding problems with delays, Judge
    Kaufman wants us to share specific case numbers so they can look into the issue
    directly if you have case examples, share this information to Stephanie Davidson at
    LAFLA for compilation and forwarding
- Entering ROs in CLETS and CARPOS
  - no updates

### IV. Legislative Issues

- a. SB320 re: firearms (enacted) implementation issues
  - Pallavi reports that the Judicial Council reached out to her and scheduled a call to discuss training issues in regards to DV & firearm relinquishment, and she will report back at the next meeting
- b. SB 662 re: court reports/recording (held in committee) issues while awaiting passage
  - committee members report that they have generally been filing FW-020s in all applicable cases and have not experienced any problems
  - Rachelle reports back from FLC meeting where Judge Kauffman noted there may be shortages around holiday weekends which could cause unavailability of reporters even when requested in advance
- c. AB 2791 re: Sheriff service provision prohibiting substantive review is active, implementation issues (email/fax signature goes into effect 1/1/24)
  - Addressed above in regards to upcoming meeting w/ sheriff

### V. Emerging Issues

- Pallavi raises issue of SCOTUS taking up Rahimi case regarding 2<sup>nd</sup> amendment & DV; deadline to submit amicus is August 31<sup>st</sup>
  - Minty notes CPEDV sent out call for survivor stories (on behalf of DC coalition), will send to DVC for circulation;
  - Gail recommends reaching out to death review teams for data on how many deaths were by firearm
- VI. Parking Lot: (i) FC 6306 Criminal Record Searches, (ii) SA/HT RO; (iii) Rulings on FW-002; (iv) EPOs tracking time between issuance of EPO / first attempt, and denials in the case of delay between incident and report law enforcement or judicial issue?; (v) implementation of coercive control legislation
  - Pallavi will try to ask about these issues during her call with Judicial Council tomorrow
- VII. Matters not on the posted agenda (to be presented and placed on a future agenda)
  - Gail inquires about possible new funding stream for legal aid mentioned during Q&A with Mandated Supporter Initiative presentation to general meeting; Minyong had asked that question to Tamara, so she may follow up, but notes federal funding is hard to tap into
