Introduction/Announcements – individual introductions conducted

Some State Policy while awaiting late arrivals. . .

We are in the 2d year of a two year legislative cycle, some bills from last year that died or were held may resurface; on the positive side Governor's budget does not have cuts to victims services. Governor's proposed budget shows a 388B shortfall and the LAO's calculates at 58B shortfall. While there is a budget gap; the percentage is not bad as it was in 2009; this time, state has reserve funds. The shortfalls in the Governor's budget might be filled by cuts to affordable housing, and the hope of filling in the \$200M VOCA fix will be a heavy lift. Remember that this is just a proposal, not the final budget. There's lots of room between here and final budget. There will be things that will be funded which are not currently being proposed to be funded. Assembly budget due 1/22, revised budget in mid-May, then there will be additional hearings.

Leadership has had 2 major changes; new speaker of Assembly Rivas and new President Pro Temp Mike McGuire. We have a shift in geographic power. Fortunately Jesse Gabriel will be new Assembly Budget Chair, and he has existing relationships with JFS and Haven Hills and sponsored gun violence bill last year.

Planning for the Year Ahead

Nancy has a new job, but will retain her appointment as CD5 rep as a volunteer. However, will need a volunteer who can, or who has a paralegal or intern who can, maintain the bill chart. In the months ahead, Lan may have staffer who can help, but in the interim. . . graciously and generously, Stephanie W volunteers. However, if anyone else has capacity to support, feel free. Set up is a bit of work, but after that, it's a commitment of one afternoon in the beginning of the week of our monthly meeting during the legislative season.
