## LEGISLATIVE ISSUES

State: Nancy notes that she has split the bill chart into two versions. The Final chart and the chart that includes dead bills. If you are receiving this year's bill chart, your email will be included to receive next year's 2025 Bill chart.

Review bill chart for final updates. Note that only a few bills will have a substantive impact on our clients. Still a successful year for legislation in light of a very bad budget year.

Federal: new federal fixes approved, but note that the federal fixes proposed are things that have already been implemented in CA. There has been no movement on the VOCA fix. Congress passed short term funding though the election to avoid a government shutdown and is punting the government budget to the next legislature.

\*\*VOTE\*\* encourage clients, friends, and coworkers to vote for themselves and for those who can't vote. November 5, 2024 is Election Day, but you can vote NOW; mail ballots have been sent out. Early in person voting starts on October 26. For those who miss the October 21 online/mail deadline for voter registration, Adam reminds everyone that CA allows for same day in person registration on Election Day.
