- ✓ The plans will be reviewed within 20 working days of receipt of your fee, application and plans. The plan checker will contact you when your plans are completed.
- ✓ The initial plan check fee entitles you to a maximum of two <u>plan reviews</u>. A charge of \$43 per hour will be assessed for all subsequent plan reviews.
- ✓ The initial plan check fee entitles you to a maximum of two field inspections. A charge of \$43 per hour will be assessed for all subsequent <u>field inspections</u>.
- ✓ Your plans are now in line for review. Your plan checker will contact you when your plans are ready.
- ✓ Plans NOT APPROVED must be resubmitted. Please call your plan checker for an appointment.
