# MEASLES INVESTIGATION Checklist 1: Symptomatic Case-patient

### 1. Clinical Assessment of Case-patient

- □ Read IRIS notes written by the Vaccine Preventable Disease Control Program (VPDCP)
- Make home visit
- Document rash onset date and duration
- Document rash onset location on body and progression
- $\hfill\square$  Document fever onset date and duration
- □ Document any of the 3 C's (cough, coryza, conjunctivitis)
- Document case-patient's immune-compromised state at the time of exposure and currently

### □ 2. Isolation/Exclusion of Case-patient from Activity

- Determine status of case-patient (e.g., has symptoms of febrile rash, confirmed to have measles by DPH, hospitalized)
- □ Isolate or exclude from activity according to the status of case-patient (see B-73)
- □ Contact VPDCP for all other institutional exposure isolation procedures
- □ 3. Obtain any needed specimens (urine, throat and serum) for measles testing
  - □ Arrange for courier pick up of specimens to Public Health Lab. M-F 8:00 am 5:00 pm, contact Central Accessioning at (562) 658-1460. After hours call (213) 974-1234 and ask for the Public Health Laboratory Director.
  - □ Notify VPDCP via email to vpdc@ph.lacounty.gov and the VPDCP lead investigator listed in IRIS notes) of any specimens that have been collected.
  - Lab results for all available tested specimens obtained from the Public Health Lab and VPDCP

### 3. Assessment of Immunization History, Prophylaxis, Attempted Treatments

- Determine case-patient's immunization history with dates and doses (obtain vaccination record)
- Did the case-patient receive an MMR within the last 3 months?
- Did the case-patient receive measles IG within the last 1 year?
- Did the case-patient take any antibiotics within the last 4 weeks?

4. Establish the source of exposure to the case-patient (7-21 days prior to rash onset)

- □ Provide case-patient the Measles Activity Log VPDCP with dates of all sites visited by casepatient as possible exposure sources to case-patient (VPDCP can assist with the dates)
- □ Did the case-patient travel anywhere or attend any large public gatherings/parks during the 4 weeks before the rash onset date?
- □ Did the case-patient have any out-of-town visitors during the 4 weeks before the rash onset date?
- $\square$  What is the occupation and work site details of the case-patient? Healthcare worker? Infant care

#### □ 5. Identify contacts exposed to the case-patient

- □ Determine the infectious period of the case-patient (± 4 days from rash onset date)
- Establish the exposure sites the case-patient may have visited while infectious (consider household, school, daycare, worksite, gym, carpools, social activities, religious activities, clubs, airplanes, clinics, pharmacies, etc.).
- Determine the dates of attendance at these exposure sites. Do they overlap with the infectious period dates?
- □ Provide the case-patient the Measles Activity Log VPDCP with the infectious dates indicated so the case- patient can determine the possible exposure sites.
- □ Has the case-patient been around any high-risk contacts (e.g., infants < 12 months of age, pregnant women, immunocompromised persons, health care workers)?
- Proceed in completing the VPDCP Measles Investigation Checklist 2 for Asymptomatic Contacts of a Measles Case
- □ 6. Diagnosis of measles in the case-patient

 $\hfill\square$  Consult with VPDCP as to the final diagnosis of measles in the case-patient
