### Goal 1 Objectives & Draft Strategies

#### **GOAL 1:** To increase access to and improve quality of health care.

STRATEGY 1: Engage and collaborate with partners to identify high-need providers for asthma education.

#### OBJECTIVE(S) SUPPORTED:

- 1.1 Advocate for professional development opportunities for asthma health care providers and community health workers/promotores de salud.
- 1.2 Identify and promote implementation of guidelines and best practices for asthma management.
- 1.4 Promote access to high quality asthma care for underserved populations in Los Angeles County and advocate for strategies to reduce barriers to care.

STRATEGY 2: Invite LBACA to offer a PACE training or model a training for the ACLAC (consider offering CMEs and obtaining funding; consider partnering with LA Care, who is currently visiting doctor's offices individually).

- 1.1 Advocate for professional development opportunities for asthma health care providers and community health workers/promotores de salud.
- 1.3 Advocate for coverage, reimbursement, and on-going quality improvement for comprehensive asthma care.

STRATEGY 4: Identify potentially interested partners who want to begin offering mobile asthma services (e.g. Dr. Melnick) and collaborate with the Breathmobile to provide technical assistance and consultation to other groups that want to provide mobile asthma services (e.g. a hospital or non-profit in Antelope Valley).

STRATEGY 5: Apply for funding to change the Breathmobile electronic medical record (EMR) system to add the AAP developed by the ACLAC, which will include the disclaimer statement/signatures needed by school nurses.

- 3. List the corresponding objective(s) from the Strategic Plan for Asthma in California.
- 4. For each strategy, list the major activities in chronological order.
- 5. For each key activity, identify the person(s) responsible, the time frame, and the due date.
- 6. For consistency use a "verb-object" format: Start each activity with a verb followed by the objects acted upon.
- 7. Update the work plan periodically to indicate the progress or completion of each activity.

Keep in mind...you do not need to address all of your objectives in your Year 1 work plan. You have 5 years total to address all of your objectives, so be realistic with your activities.
