PUBLIC HEALTH NURSE

The Clinical Guidance & Nursing Unit within the Division of HIV and STD Programs (DHSP)/Clinical Guidance & Nursing Unit (CGN), is seeking an experienced Public Health Nurse transfer who is interested in providing nursing services to promote the well-being of Los Angeles County residents and prevent disease, disability, and premature death due to sexually transmitted diseases (STD).

Minimum Requirements:

- A license to practice as a Registered Nurse and a Public Health Nurse Certificate issued by the California Board of Registered Nursing and a valid California Class C Driver License
- Must currently hold the payroll title of a Public Health Nurse (lateral transfer).

Desirable Qualifications:

- Experience with Level I Casewatch Database
- At least 2-year District Public Health Nursing experience or related field experience.
- Experience and comfort with administration of intramuscular injections (IM) and Venipuncture Specimen Collection
- Master's-level Public Health training from an accredited institution preferred (MSN or MPH)
- Exceptional oral and written communication skills, with strong analytic and critical reasoning skills
- Excellent interpersonal and collaboration skills
- Strong organizational skills
- Proficiency in Microsoft Office and Software/Hardware

Examples of Duties

- Consultation to public/private sector providers, district health centers on STD reporting, screening, treatment, case management, and CDC guidelines
- Providing sexually transmitted disease consultative services to assigned hospitals, local health centers, and public/private
 agencies concerned with patient care.
- · Assessing and evaluating STD data and trends affecting Los Angeles County residents
- Participating in STD Outreach with community agencies and service planning areas
- Providing public health education and training to various groups through public speaking, multimedia presentations, and written materials on sexually transmitted diseases
- Utilizing various computer data base programs for case management and surveillance purposes
- Performing and interpreting diagnostic procedures and administers therapeutic treatments and preventive measures in accordance with medical orders or standardized procedures.
- Participates in conducting field investigations of suspect STD/HIV events (or) outbreaks for various persons such as those persons experiencing homelessness (PEH).
- Makes home and other field visits for persons infected with STDs/HIV.

Interested individuals should submit a cover letter, resume, and last two (2) Performance Evaluations for the last two (2) years no later than **July 2**, **2024**.
