- b) Proposed amendments to Task Force Charter
  Task Force members discussed and voted on proposed changes to their charter to improve the effectiveness and functioning of the Task Force and adding clarifying language regarding processes and procedures.
- Decision: A motion was approved to accept the proposed changes in the Task Force charter effective immediately.
