The purpose of public health accreditation is consistent with our mission

Public health accreditation aims to improve and protect the health of the public by advancing the **quality** and **performance** of public health departments

Ultimate outcomes for the public health field:


- Strengthened public health agencies and systems
- Improved conditions in which people can be healthy
- Improved community health indicators/ reduced health disparities
- Increased capacity for maximum return on investment
- Increased public recognition of public health role and value

Accreditation provides health departments with a structured framework to assess performance


To become accredited, health departments must demonstrate their capacity to meet the Public Health Accreditation Board (PHAB) standards and measures

- Domain 1: **Assess**
- Domain 2: **Investigate**
- Domain 3: **Inform & Educate**
- Domain 4: **Community Engagement**
- Domain 5: **Policies & Plans**
- Domain 6: **Public Health Laws**
- Domain 7: **Access to Care**
- Domain 8: **Workforce**
- Domain 9: **Quality Improvement**
- Domain 10: **Evidence-Based Practices**
- Domain 11: **Administration & Management**
- Domain 12: **Governance**



II. Accreditation Aligns with DPH Activities

The PHAB's framework is aligned with our Department's **10 key public health actions**, making accreditation a relevant tool to help advance mission and improve our performance.



10 KEY PUBLIC HEALTH ACTIONS

The Los Angeles County Department of Public Health protects and improves the health of our community by performing these key actions:

- 1. MONITOR**
Find health problems in the community.
- 2. DIAGNOSE**
Find what causes health problems.
- 3. INFORM, EDUCATE, AND EMPOWER**
Teach people about health problems.
- 4. MOBILIZE**
Work with the community to find and solve health problems.
- 5. DEVELOP**
Make rules and plans that help individual and community health.
- 6. ENFORCE**
Make sure rules are followed so that people are safe and their health is protected.
- 7. LINK**
Make sure there are enough medical services for people who need them.
- 8. ASSURE**
Make sure our employees are prepared to do their job well.
- 9. EVALUATE**
Make sure our programs are working and doing a good job.
- 10. RESEARCH**
Study new ways to solve health problems.

II. Accreditation Aligns with DPH Activities

Accreditation provides a process designed to stimulate and accelerate efforts to reach the department's goals and objectives

Example: To address a standard under Domain 5 (Policies & Plans), health departments must adopt and implement a Strategic Plan and include reports of progress towards the plan's goals and objectives



II. Accreditation Aligns with DPH Activities

Accreditation promotes opportunities to strengthen the organization's infrastructure by refining existing procedures or processes

Example: Health departments must implement a performance management system and use a process to report on the achievement of goals, objectives, and measures (Domain 9)

- In 2008, the LA County Department of Public Health implemented a performance management system to monitor progress towards the Department's performance measures
- To enhance the existing performance management system and improve the reporting process, a Performance Improvement Application (PIA) was developed




II. Accreditation Aligns with DPH Activities

The Performance Improvement Application (PIA)

serves as the Department's database of performance measures


- PI data collection is completed online
- Using the PIA has decreased the total number of steps and time required to complete the data collection process

III. Why Seek Accreditation?

Some incentives for public health accreditation include:

- ✓ Accreditation as a potential condition of future funding
- ✓ Potential streamlining of grant reporting for accredited health departments
- ✓ Opportunities to contribute to the early evidence-base around public health accreditation



III. Why Seek Accreditation?

The accreditation process creates opportunities to strengthen external relationships

- ✓ Processes that solicit community input & engagement
 - Example: Community Health Assessment
- ✓ Plans that encourage cross-sector partnerships to reach goals
 - Example: Community Health Improvement Plan
- ✓ National recognition for excellence
 - Increases visibility & public awareness of the health department's role and value
 - Strengthens public trust



III. Why Seek Accreditation?

- Increased value
- Accelerated growth
- Enhanced innovation
- Improved collaboration
- Stronger partnering
- Better execution

IV. What is Needed to Obtain Accreditation?

Completing the accreditation process will take:

- ✓ Support of the public health department leadership
- ✓ Involvement of staff throughout the department
 - The Accreditation Team includes an advisory council, domain champions, and performance improvement team members
- ✓ Recognition that accreditation is about continuous quality improvement



Summary

- Accreditation focuses on continuous quality improvement as a means to improve the public's health
- Accreditation can be used to accelerate efforts to reach our goals
- Other potential benefits of accreditation include strengthened partnerships, national recognition for excellent public health practice, and a stronger constituency for public health funding and infrastructure
