Purpose:

Below is a non-exhaustive list of potential data aggregation platforms and vendors that can meet the requirements for data aggregation software implementation. Different provider agencies will have different needs depending on current capabilities and priorities. **This list is for informational purposes only.** Please do your own research to determine which solution best fits your provider agency's needs.

Data Aggregation Platforms:

The following platforms are commonly used for data aggregation and analysis. Each platform below is also verified as having Health Insurance Portability and Accountability Act (HIPAA) compliant configurations. Most of these platforms have been reviewed by the PAC Data Workgroup (excluding Google Looker Studio). A more detailed comparison is available in the Project Management & Data Aggregation Platform Comparison document developed by the PAC Data Workgroup and included in page two of this document.

- **PowerBI** (<u>link</u>): Cloud-based business intelligence platform owned by Microsoft. Integrates deeply with the Microsoft 365 ecosystem.
- **Tableau** (<u>link</u>): Data visualization platform known for its user-friendly drag-and-drop functionality.
- Monday.com (<u>link</u>): Customer Relationship Management (CRM) platform offering dashboards and reporting as well as integrations into communications apps such as Slack, Teams, and Zoom.
- **Zoho** (link): Cloud-based platform with AI-support, ease of use, and built-in collaboration tools.
- **Google Looker Studio** (<u>link</u>): Web-based platform with drag-and-drop visualization, real-time collaboration, and integration into the Google ecosystem.

A summary of commercial project management and data aggregation platforms is provided below. These platforms are used for organizational across various sectors (e.g., sales, health, etc.). Key features are highlighted as well as potential use for Provider Advisory Committee (PAC) Provider Data Workgroup focus areas (i.e., Clinical, Financial, Workforce, and Organizational). Pricing for platforms generally ranges from \$5 to \$25 per user and enterprise pricing will vary.
