

## Los Angeles County Department of Public Health Non-Exhaustive Lists of Prohibited and Permitted Tobacco Products

This non-exhaustive Flavored Tobacco Products list is produced to facilitate compliance with and enforcement of the County of Los Angeles' prohibition on the sale of flavored tobacco products, Los Angeles County Code § 11.35.070(E). The Flavored Tobacco Products List includes tobacco products that the Los Angeles County Department of Public Health (Public Health) has determined to be flavored, pursuant to Los Angeles County Code § 11.35.020(C)(J). Flavored tobacco products on this list are prohibited (banned) from being sold in unincorporated areas of Los Angeles County.

This document also includes a non-exhaustive list of tobacco products that Public Health has determined may be sold in unincorporated areas of Los Angeles County. This includes tobacco products that Public Health has determined are nonflavored, and tobacco products that Public Health is unable to make a determination for (i.e., undetermined), and thus may be sold.

Public Health reserves the right to amend this document pursuant to the Los Angeles County Code § 11.35.020(C), as new information becomes available.

Please note, this applies only to the retail sale of flavored tobacco products in unincorporated areas of Los Angeles County. Possession of flavored tobacco products for personal use is permitted.
