#### Subject: CERTIFICATE FOR INTERSTATE MOVEMENT OF SMALL ANIMALS

The health certificate used for the movement of small animals has been revised. Enclosed please find the revised *Certificate for Interstate Movement of Small Animals (Form 77-043)*. This form is for *interstate movement use only*. Blank certificates can be downloaded from our website (www.cdfa.ca.gov) and duplicated as needed. To locate the small animal health certificate on the CDFA website home page, use the search box located in the top right hand corner. Type "Small Animal Health Certificate" and then click the magnifying glass. The certificate may be printed on white paper. The California Department of Food and Agriculture (CDFA)-Animal Health Branch no longer produces or distributes carbon-copy small animal health certificates.

For *international movements* of small animals use the *United States Interstate and International Certificate of Health Examination for Small Animals (APHIS Form 7001)*. Please contact the USDA-APHIS Office for forms and additional international movement information. Also, contact the country of destination as some countries require a specific health certificate.

## GENERAL INFORMATION ON ANIMAL MOVEMENT FOR ACCREDITED VETERINARIANS

#### A. Movement Requirements

- 1. Obtain information regarding interstate movements of animals from:
  - State of Destination
  - CDFA website http://www.cdfa.ca.gov/ahfss/Animal\_Health/Permits.html
  - USDA website http://www.aphis.usda.gov/import export/animals/animal import/animal imports states.shtml

#### 2. Obtain information regarding **international** movements of animals from:

- 3. Check with airlines for additional movement requirements.

#### **B.** Responsibilities of Accredited Veterinarians

- 1. Certificates must:
  - Comply with state of destination and airline requirements.
  - Be issued only after federal requirements (9 CFR Part 161) are met.

2. Information about common certificate omissions and errors is enclosed.

## C. Distribution of Certificates

- 1. Certificate for Interstate Movement of Small Animals (Form 77-043):
  - Send copies of the certificate to the state of destination within 10 days of shipment.
  - Do not send a copy of the completed certificate to this office.
  - Blank certificates may be downloaded from CDFA website and duplicated as needed, unless state of destination has specific certificate requirements.
  - Certificates are void 30 days after inspection of animal; check with the airline for specific requirements regarding health certificates.

## 2. Certificates of Veterinary Inspection (Form 77-010) for livestock and poultry:

- Distribute as indicated on the form.
- Send copies of completed/voided certificates to CDFA Headquarters Office within 10 days of issue.
- Certificates become void 30 days after inspection of animals.

## 3. U.S. Interstate and International Certificate of Examination for Small Animals (APHIS Form 7001):

- Send copies of the certificate to the USDA office in California within 10 days of shipment.
- Do not send a copy of the completed certificate to this office.

- Certificates are void 30 days after inspection of animals; check with the airline for specific requirements regarding health certificates.
- Check the country of destination for specific requirements.

## **D.** Ordering Certificates

- Certificate for Interstate Movement of Small Animals (Form 77-043) may be obtained by downloading the certificate from the CDFA web site (<u>http://www.cdfa.ca.gov</u>). Use the search feature; type in "Small Animal Health Certificate".

## Subject: COMPLETING CERTIFICATES OF VETERINARY INSPECTION (FORM 77-010)

Accredited veterinarians are responsible for issuing accurate complete certificates of veterinary inspection (CVI). Timely submission of CVI reduces the risk of disease introduction and spread.

Record all applicable information pertaining to animal(s) shipped on CVI, including individual animal identification, complete origin/destination information and complete test results. Keep a copy for your records.

Check with the state of destination for their entry requirements. Additional movement requirements can be found on the CDFA website (<u>http://www.cdfa.ca.gov/ahfss/Animal\_Health/Permits.html</u>) and the USDA website (<u>http://www.aphis.usda.gov/import\_export/animals/animal\_import/animal\_imports\_states.shtml</u>).

• Incomplete, inaccurate or omitted name and address

- No entry permit obtained
- Permit number not recorded

## **Species:**

• Not checked/cannot determine

• Not included

## **Official Individual Animal Identification:**

• Omitted (Important for interpreting tests & eligibility for entry)

• Missing test or test information (Include date, hour of injection, observation and result)

## **Trichomonosis Test:**

• Missing test or test information (Include laboratory name, date of negative test and results)

## **Brucellosis Test:**

• Missing test or test information (Include date of negative test, lab name, type of test, and results)
